

**ROOSEVELT COUNTY ELECTRIC**  
**2020 Scholarship Application**  
**Returning College Students**

A one-year scholarship, in an amount to be determined on an annual basis by the Roosevelt County Electric Education Foundation, will be considered under the following guidelines:

**ELIGIBILITY**

All criteria listed below must be met:

1. Available to dependents of members receiving service from Roosevelt County Electric Cooperative, Inc. or a legal dependent of a full-time employee of a member receiving service from the cooperative and said employee must be living in a residence connected in the member's name.
2. Scholarships to be granted to attend an accredited vocational school, technical school, college, or university
3. Applicant must be of good character as evidenced by a minimum of two (2) letters of recommendation of which at least one (1) must be from a teacher, professor, counselor, etc., from the institution they are currently attending.
4. Applicant must maintain at least a 2.5 grade point average on a 4.0 point scale and be considered by the registrar to be a full-time student in good standing (minimum of 12 credit hours).

**SELECTION PROCESS**

Recipients will be determined by the Roosevelt County Electric Education Foundation selection committee.

**THESE ARE ONE (1) YEAR SCHOLARSHIPS. PERSONS WHO WISH TO RECEIVE A FUTURE SCHOLARSHIP MUST RE-APPLY EACH YEAR. SCHOLARSHIPS WILL BE AWARDED ON THE CRITERIA SET FORTH ABOVE. SCHOLARSHIPS IN THE AMOUNT OF \$500 OR LESS WILL BE PAID IN ONE INSTALLMENT UPON PROOF OF ENROLLMENT AND CURRENT GPA OF 2.50.**

1. Completed and signed scholarship application.
2. Written proof of current overall GPA of 2.5 or better and full-time student status
3. Applicant must be of good character as evidenced by a minimum of two (2) letters of recommendation of which at least one (1) must be from a teacher, professor, counselor, etc., from the institution they are currently attending.
4. One page or less typed or handwritten essay on how this scholarship will aid applicant in their educational goals.
